पीएच मतलब क्या होता है :- पीएच का पूरा मतलब होता है- पोटेण्डियल ऑफ हाइड्रोजन यानी हाइड्रोजन की क्षमता। हाइड्रोजन के अणु किसी चीज में उसकी अम्लीय या क्षारीय प्रवृत्ति को तय करते हैं। मतलब अगर किसी लिक्विड या प्रोडक्ट का पीएच 1 या 2 है तो वो अम्लीय (Acidic) है और अगर पीएच 13 या 14 है तो वो क्षारीय (Alkaline) है। अगर पीएच 7 है तो वह न्यूट्रल (Neutral) है।

यदि पानी में टीडीएस की अतिरिक्त मात्रा:- टीडीएस (टोटल डिजॉल्व्ड सॉलिड) यानि पानी में घुले सूक्ष्म पदार्थ। इनमें सोडियम, फ्लोराइड, आयरन, क्लोराइड, कैल्शियम, मैग्नीशियम, नाइट्रेट जैसे पदार्थ होते हैं। यह मानव शरीर को नुकसान पहुंचा सकते हैं। अधिक टीडीएस वाला पानी पीने से व्यक्ति को उल्टी दस्त, बुखार, घबराहट होना, किडनी में पथरी के साथ कई तरह की बीमारियां हो सकती हैं। पथरी की शिकायत होने पर उसका समय पर उपचार करवाना जरूरी है।



यदि पानी में हार्डनेस की अतिरिक्त मात्रा:- हार्ड वाटर उसे कहा जाता है जिसमें कैल्शियम और मैग्नीशियम की मात्रा अधिक होती है। अत्यधिक हार्डनेस न पीने योग्य होता है न ही अन्य उपयोग के लिए सही होता है, अतिरिक्त मात्रा में हार्डनेस हमारे शरीर के लिए नुकसानदायक है, हमारे गुर्दे प्रभावित होते हैं और हमारे बाल झड़ने लगते हैं।

बक्टोस्कोप परीक्षण:- पानी की सुक्ष्मजीविय गुणवत्ता को जाचने के लिए बक्टोस्कोप परीक्षण करना अत्यधिक आवश्यक है, क्योंकि पानी से होने वाली बीमारी जैसे - टाइफाइड, कॉलरा, दस्त और पीलिया जैसी बीमारी होने के कारण बनते हैं।

संक्रामक रोग दूषित पानी के माध्यम से फैल सकता है, इन सुक्ष्मजीवों के उत्पन्न होने से कई बीमारियों की उत्पत्ति होती है जैसे टाइफाइड, कॉलरा, पैराटाइफाइड बुखार, डिसेंटरी, पीलिया, अम्बिसिस और मलेरिया आदि। पानी के रसायनों से भी हमारे स्वास्थ्य शरीर पर नकारात्मक प्रभाव पड़ता है।

बिना पानी की जाँच से पानी में मल संक्रमण (fecal contamination) की मात्रा होना दस्त का प्रमुख कारण होता है। काम्प्लोबक्टेर जेजुनी बैक्टीरिया दुनिया भर में डाइरिया 4% से 15% फैल गया है। बुखार, पेटदर्द, सिरदर्द, दस्त के प्रमुख लक्षण हैं।







WHEREAS:

This MOU signifies the collaborative efforts of both entities to advance the realms of innovation, incubation, and entrepreneurial empowerment within the educational landscape of Nagpur.
- b) The primary purpose of this MOU is to establish a mutually beneficial partnership between INCUBEIN FOUNDATION and SUDHA SURESHBHAI MANIAR COLLEGE OF COMPUTER & MANAGEMENT, with the overarching goal of promoting and nurturing a vibrant ecosystem of entrepreneurship, skill development, and employability. By leveraging each party's unique strengths, resources, and expertise, this partnership aims to cultivate a conducive environment that encourages students, faculty members, and aspiring entrepreneurs to embark on transformative journeys of ideation, innovation, and business creation.
- c) Through this collaboration, INCUBEIN FOUNDATION seeks to extend its network and influence to SUDHA SURESHBHAI MANIAR COLLEGE OF COMPUTER & MANAGEMENT and its affiliates, thereby enabling the dissemination of invaluable knowledge, guidance, and support related to entrepreneurship and innovation. The alliance aspires to empower students and faculty members by equipping them with the tools, mentorship, and opportunities necessary to translate their innovative ideas into impactful ventures that contribute to societal and economic growth.
- d) Furthermore, this MOU outlines the responsibilities, commitments, and mechanisms for cooperation between INCUBEIN FOUNDATION and SUDHA SURESHBHAI MANIAR COLLEGE OF COMPUTER & MANAGEMENT, aiming to provide a structured framework for joint initiatives, knowledge exchange, capacity building, and the establishment of an incubation sub-center within the campus. The ultimate aim is to create a thriving ecosystem where innovation is nurtured, entrepreneurial aspirations are realized, and the intellectual potential of students and faculty members is harnessed to shape a brighter future for the community and beyond.

Role and Responsibilities


1. **Knowledge Sharing and Capacity Building:** INCUBEIN FOUNDATION and INCUBEIN SUB-CENTER shall collaboratively share available facilities, which may include office space, laboratories, equipment, and resources, for the benefit of startups and incubatees. The sharing arrangement shall be determined through mutual agreement, considering the practicality and sustainability of costs.

3. **Empowerment of Sub-Center Leadership:** INCUBEIN FOUNDATION shall collaborate closely with the designated In-Charge of INCUBEIN SUB-CENTER and their dedicated team (consist of Teacher, Students and Alumni and representative from Incubein Foundation) to ensure effective management, coordination, and successful implementation of all incubation-related endeavors. Notably, the Sub-Center will add representative from INCUBEIN FOUNDATION to join their leadership team, contributing valuable insights and mentorship. This collaborative leadership approach will be prominently displayed on the Sub-Center's official website, showcasing the shared commitment to fostering innovation, entrepreneurship, and impactful ventures within the academic community.
4. **Provision of Research and Development Space:** INCUBEIN FOUNDATION shall allocate dedicated space within its premises for startups affiliated with INCUBEIN SUB-CENTER conduct research, development, and innovation activities. The allocation of space shall be contingent upon the feasibility and strategic alignment of the projects.
5. **Intellectual Property and Product Commercialization:** The final market-ready product developed through collaboration between INCUBEIN FOUNDATION and INCUBEIN SUB-CENTER shall be jointly owned and managed by both parties. The rights to patents, copyrights, and other intellectual property arising from such collaboration shall be equitably distributed based on contributions. The specifics of Intellectual property ownership and commercialization shall be outlined in a separate Intellectual Property Agreement to be mutually agreed upon.
6. **Technical Assistance and Internship Programs:** INCUBEIN FOUNDATION shall extend comprehensive technical support, mentorship, and advisory services to startups incubated under INCUBEIN SUB-CENTER. Additionally, INCUBEIN FOUNDATION may offer opportunities for interns from its incubation center to engage in projects hosted by INCUBEIN SUB-CENTER, providing valuable experiential learning to students and contributing to their skill development.

INCUBEIN FOUNDATION shall remain committed to offering ongoing assistance, expertise, and support to INCUBEIN SUB-CENTER ensuring its sustained growth and impact within the academic and entrepreneurial community.

12. **Faculty Engagement and Expertise Sharing:** INCUBEIN SUB-CENTER shall provide comprehensive details of its faculty members, including their areas of expertise, research interests, and industry experience, to INCUBEIN FOUNDATION. This information shall facilitate targeted mentorship, collaboration, and resource allocation to align with the expertise of faculty members and enhance the overall value proposition for startups.

13. **Student Outreach and Engagement:** INCUBEIN FOUNDATION and INCUBEIN SUB-CENTER shall collaborate to disseminate information, updates, and opportunities related to entrepreneurship, innovation, and incubation to the student body. Regular communication channels shall be established to ensure that students are informed about workshops, events, internship opportunities, and initiatives, fostering active student engagement and participation. 14. **Collaborative Problem-Solving:** INCUBEIN SUB-CENTER shall maintain open lines of communication with INCUBEIN FOUNDATION, regularly sharing updates on the activities, progress, challenges, and requirements of its incubation team. This collaborative approach shall enable INCUBEIN FOUNDATION to provide timely solutions, support, and guidance to address challenges and ensure the effective functioning of the Incubation Sub-Center.

15. **Program Planning and Execution:** INCUBEIN FOUNDATION and INCUBEIN SUB-CENTER shall jointly conceptualize, plan, and execute a diverse range of programs, including seminars, workshops, hackathons, and events. The responsibility for promotion and seamless execution of these initiatives shall be shared between both parties, aiming to engage the entrepreneurial community and foster innovation-driven learning experiences.

16. **Joint Incubation and Idea Catalysis:** INCUBEIN SUB-CENTER shall have the opportunity to collaborate with INCUBEIN FOUNDATION to elevate promising ideas and prototypes to the next level of development. Registered innovative concepts within the Sub-Center shall sign co-incubation agreement with INCUBEIN FOUNDATION, which will enhance the potential for successful entrepreneurship.


17. **Co-Incubation and Brand Usage:** In cases of co-incubation, INCUBEIN SUB-CENTER shall ensure that incubatees sign a separate agreement with INCUBEIN FOUNDATION outlining the terms and conditions of co-incubation. Furthermore, prior written permission from INCUBEIN FOUNDATION shall be sought before using the name or affiliation of INCUBEIN FOUNDATION or RTM Nagpur University in any external communications, marketing materials, or business endeavors.

19. **Dispute Resolution Mechanism:** In the event of disputes arising from this agreement or its interpretation, INCUBEIN FOUNDATION and INCUBEIN SUB-CENTER shall engage in good-faith mutual discussions to reach an amicable resolution. Should these discussions prove unsuccessful, either party or both parties may refer the matter to the Board of Directors of INCUBEIN FOUNDATION, whose decision shall be binding. The resolution process shall be governed by the principles of fairness, impartiality, and promptness.
20. **Arbitration Clause:** In cases where the resolution process outlined in the previous point is exhausted without achieving a resolution, the aggrieved party or parties shall have the option to initiate arbitration. The arbitration process shall be in accordance with the provisions of the Arbitration and Conciliation Act, 1996. The arbitrator shall be appointed by the Board of Directors of INCUBEIN FOUNDATION, considering factors such as expertise and impartiality. The arbitration proceedings shall be conducted in English and held in Nagpur, with the costs shared equally between the parties.
21. **Conduct and Integrity:** INCUBEIN SUB-CENTER shall conduct its activities and initiatives in a manner consistent with the principles, values, and interests of INCUBEIN FOUNDATION and RTM Nagpur University (RTMNU). The parties shall strive to maintain mutual respect, integrity, and professionalism throughout the collaboration. In cases of disagreements over the interpretation or conduct of activities, the decision of INCUBEIN FOUNDATION shall be deemed final and binding.
22. **Legal Expenses and Documentation:** INCUBEIN SUB-CENTER shall bear the legal expenses associated with the drafting and preparation of agreements between the parties. This shall include costs related to legal documentation, formalization of partnership arrangements, and any required agreements that govern the collaborative initiatives. The equitable distribution of legal expenses shall be mutually agreed upon during the process.


TERM AND TERMINATION

- a) This Agreement shall be effective from the date of signing and shall remain in force for a period of three years ("Initial Term").
- b) Sub-Centers shall pay a processing fee of Rs. 3000/- (Rs. Three thousand only for three years) through a Demand Draft (DD) or Cheque payable to INCUBEIN FOUNDATION upon establishing the Sub-Center.
- c) This agreement may be extended beyond the Initial Term upon mutual consent in writing, subject to a review by the INCUBEIN team based on the growth and achievements of the Sub-Center.
- d) This agreement shall continue in effect as stated above. Either party may terminate this agreement by providing one month's written notice, without requirement of assigning reasons. However, such termination shall not absolve the SUB-CENTERS and its promoters of their obligations incurred under this agreement. Furthermore, INCUBEIN reserves the right to terminate the agreement with immediate effect if it loses confidence in the SUB-CENTERS, discovers acts of omission or commission involving moral turpitude, or if such actions are detrimental to the interests of INCUBEIN. Termination may also occur if the SUB-CENTER is unable to fulfill its liabilities, faces insolvency, or if circumstances deemed undesirable by INCUBEIN/RTMNU arise.

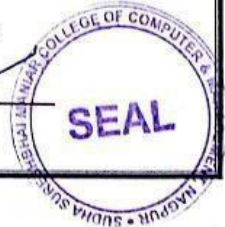
